# PRESENTATION - WARREN COUNTY DRUG TASK FORCE - COMMANDER JOHN BURKE & LT. STEVE ARRASMIT

Commander Burke stated he's retiring in October and thanked Council for all their support. Commander Burke updated Council on some of the activities of the Warren County Drug Task Force from the past year. He noted that personnel has been expanded; part of Ohio HIDTA, a joint effort to combat high level drug trafficking organizations in the United States; a Police Officer from Franklin is on the Task Force and have a full-time prescription person and financial crime investigator. Commander Burke then introduced Lt. Steve Arrasmit who is his replacement, to begin October 24<sup>th</sup>.

Lt. Arrasmit introduced himself to Council and that he's been with the Sherriff's Department 23 years. He thanked Council for the continued support and added he will continue going in the same direction.

Mayor Centers thanked them for what they do and that we also appreciate the job they do.

## PRESENTATION - MIAMI CONSERVANCY DISTRICT 100<sup>TH</sup> ANNIVERSARY PROCLAMATION

Mayor Centers presented a Proclamation to the Miami Conservancy District in recognition of their 100<sup>th</sup> Anniversary on June 28, 2015 to Mr. Kurt Rinehart.

PUBLIC HEARING ORDINANCE 2015-07 AMENDING SECTIONS 923.01 TO 923.04, 923.06, 923.07, 923.09 AND 923.10, AND ENACTING SECTIONS 923.05, 923.08, 923.11, 923.12 AND 923.99 OF THE CODIFIED ORDINANCES OF THE CITY OF FRANKLIN, OHIO

Mr. Lewis stated that this adds a \$2.00 per month surcharge on the storm water user fee, per utility account. It is the resident's responsibility for curb, gutter and sidewalk repair. This fee will be used to repair curb and gutter during road paving projects, removing the resident's responsibility for this cost. The City will replace the curb and gutter as we do paving projects. The Utility Committee has reviewed and recommends approval.

Mayor Centers asked if the fee is enough. Mr. Lewis stated he thinks it will be, the City will cover any remaining cost, if it's not enough. We estimate that it will provide approximately \$100,000 per year.

Mr. Lipps asked what the current storm water user fee is. Mr. Lewis stated its \$3.50 per residential unit and there is a formula used for non-residential units.

Mr. Bray asked about the sidewalk replacement program. Mr. Lewis stated we have talked about it and will be coming back with this.

Mr. Lipps asked if there will be any increase in the \$3.50 fee. Mr. Lewis stated no, and that the fee was established in 2004.

Mayor Centers opened the Public Hearing and asked for any comments. There being none, he closed the Public Hearing and asked for any Council comments.

PUBLIC HEARING ORDINANCE 2015-08 AMENDING CERTAIN SECTIONS (333.11, 335.01, 335.02, 335.031, 335.13, 335.14, 335.23, 337.16, 339.10, 339.12, 339.13, 339.14, 339.31, 341.01, 341.05, 351.12, CHAPTER 353 AND 373.08) AND ENACTING SECTION 341.051 OF THE CITY OF FRANKLIN TRAFFIC CODE TO BE CONCURRENT WITH STATE LAW THROUGH JULY 1, 2015

Ms. Fisher stated that this is our twice yearly update to keep the traffic code concurrent with State law. The big changes are to requiring new residents to get a license; added exceptions to probationary license; financial responsibility; expired license tags; handicap parking; cleaned up Section 353 and there are not a lot of big changes.

Mr. Aldridge questioned the towing vehicles section. Ms. Fisher stated the biggest changes are placed on the towing companies.

Mayor Centers stated the owner of the building wants to put a door in on the side of the building with the mural on it. We need to get hold of Eric and see if he'll look at it.

Mr. Lipps stated that the State mural is also in bad shape; maybe citizens would help financially; like for us to look at saving it.

Mayor Centers again stated, we need to get hold of Eric and see if he'll look at and he also didn't finish the mural on the Bell Building.

Mr. Greathouse stated that there is an artist at Pendleton that might be able to help.
