

Narrative

Both vehicles were moved from the original crash cite upon arrival of officers. Both Unit 1 and Unit 2 indicated they were traveling in the straight lane of travel. Unit 1 had damage to the driver's side rear fender, all the way up to the driver-side mirror. Damage appears to be from the tire of unit 2 rubbing up against the side of the vehicle. Unit 2 has minor damage to the passenger side front fender, appears to have been caused by the mirror of Unit 1. Due to being unable to determine which vehicle was in the straight lane and which was in the turning lane, neither vehicle was cited for this incident. Other than the drivers of Unit 1 and 2, there were no witness on scene to indicate what happened.

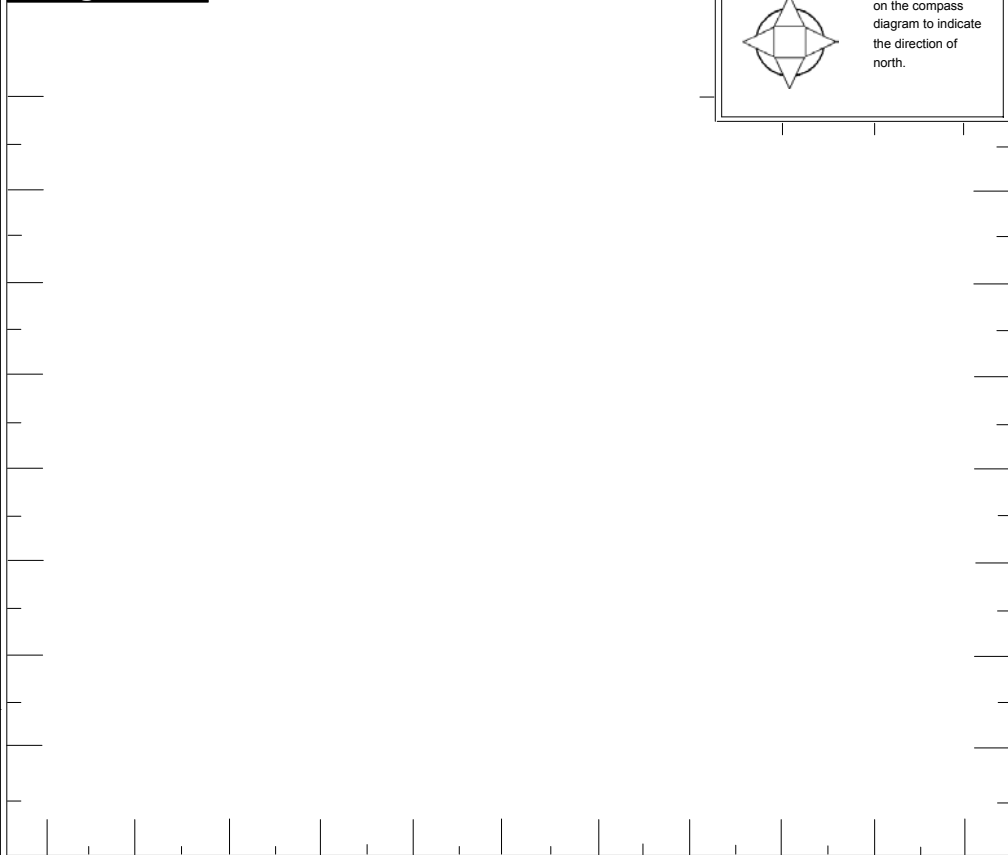
