Narrative

Unit # 1 and Unit # 2 both were traveling south bound on S. River St at Farm Ave. The driver of Unit # 2 stated she was in the left hand lane of travel at the red light waiting to turn left onto north bound S. Main St when she was struck by Unit # 1, who was also turning left onto north bound S. Main St.

The driver of Unit # 1 stated that she was stopped at the red light at S. River St and Farm Ave, she stated when her light turned green and she began her left turn she heard a bang and knew she had been in a crash.

Both Unit # 1 and Unit # 2 stated they had the right of way. They were no independent witnesses to the crash, neither driver could advised who was at the red light first. The driver at fault is unknown.

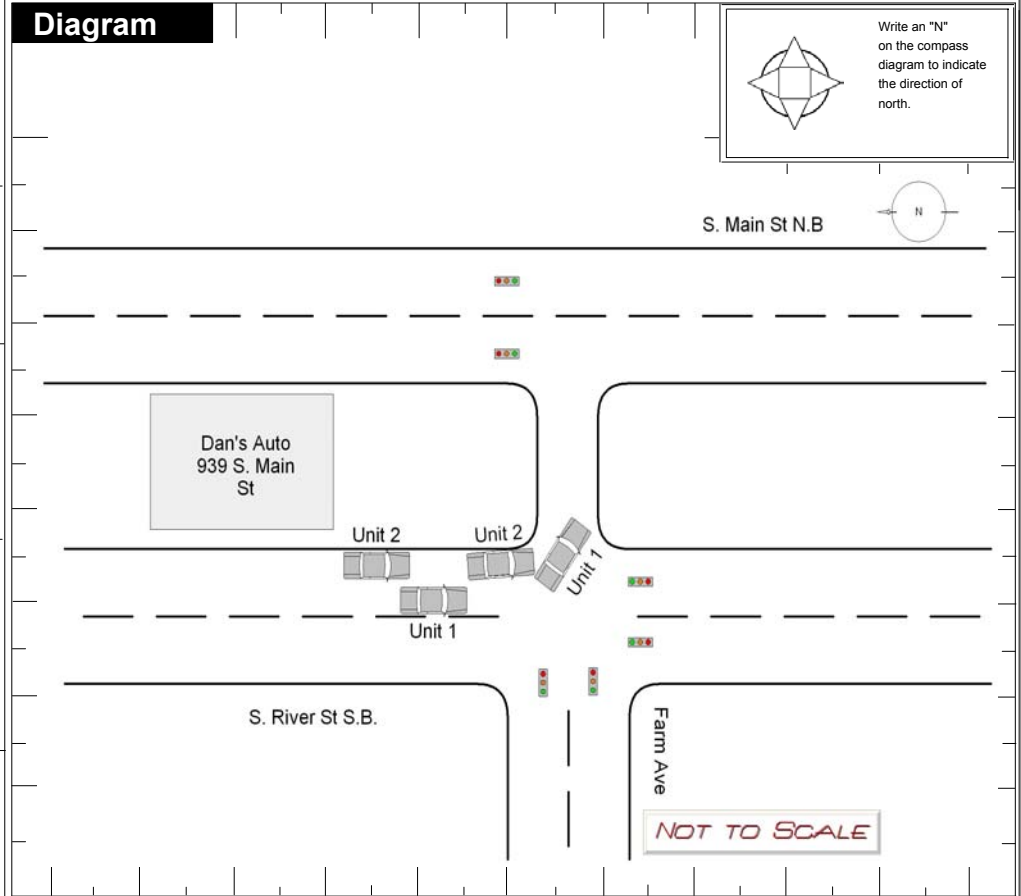
