# Narrative

On 1-24-12 at about 1558 I responded to the area of E. Second and Allen St. for an auto accident. When I arrived I found two vehicles that had been in an accident. I spoke to the drivers of those vehicles and learned the following. Unit number one was east bound on E. Second St. Unit number two was west bound on E. Second St. A deer ran from south to north across E. Second St near Highland Av. The deer was struck by unit number one which pushed it into the path of unit number two. The deer lodged under unit number two and was dragged to Allen St. where unit two stopped. Both units were disabled by the impact with the deer.

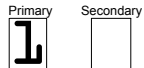

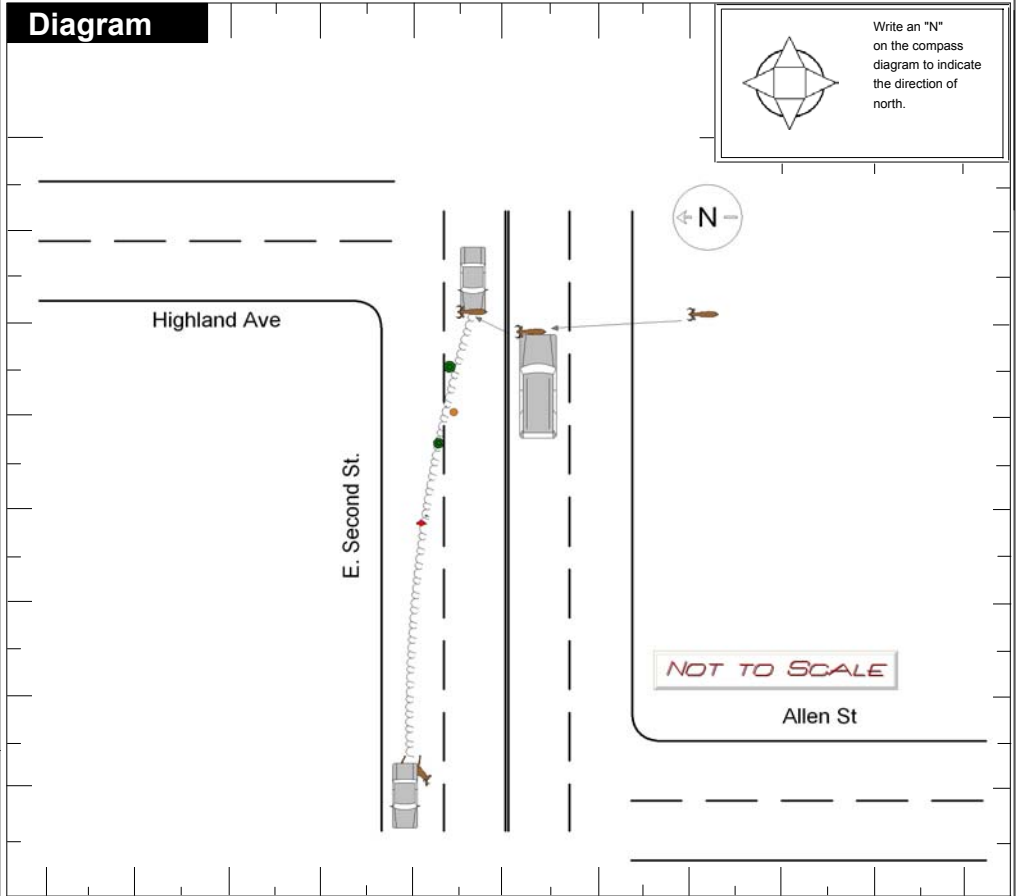
