Narrative

On 01-31-12 at about 2031 I was dispatched to the area of Hudson and S Main St for a hit-skip accident. When I arrived I spoke to the driver of unit #2, Tyler Conklin. I also spoke to the other occupants of unit #2, Gerald Pearson, Jeremy Banks and Frank Baker. I learned from them that they followed unit #1 from Farmington Rd in Miamisburg. Both units pulled into Fairway Lawn to confront each other over what had happened on Farmington Rd. While on the lot, unit #1 gunned his engine and lost traction in the gravel lot. Unit #1 hit unit #2 head-on. Unit #1 then when north on Main St, turned left onto Hudson, left onto River St, Right onto Thirkield where unit #1 struck unit #3 which was parked legally on Thirkield. Unit #1 then turned right on Farm Av. The occupants of unit #2 lost sight of unit #1 as it turned south on Main St. The occupants of unit #1 gave me the license plate number of unit #1. It returned to Edith Mock at 1115 S. Main St in Franklin. Being familiar George Mock, his SSN was checked. He is the son of Edith. All four occupants of unit #2 identified Mr. Mock as the driver of unit #1. Information taken for a report, units will attempt to locate Mr. Mock.


