Narrative

Unit 1 was stopped eastbound on W. 3rd St. preparing to turn left onto S. Main St. She began her left turn and stuck unit 2 in the driver's side. Unit 2 was westbound on W. 3rd St. crossing S. Main St. at the time of the crash. Unit 2 advised that he was stopped westbound on W. 3rd St. and as he began to cross S. Main St. he saw that Unit 1 was beginning the left turn. Unit 2 advised that he took evasive action to his right. Unit 1 advised that she checked ahead of her and saw no one prior to beginning her left turn.

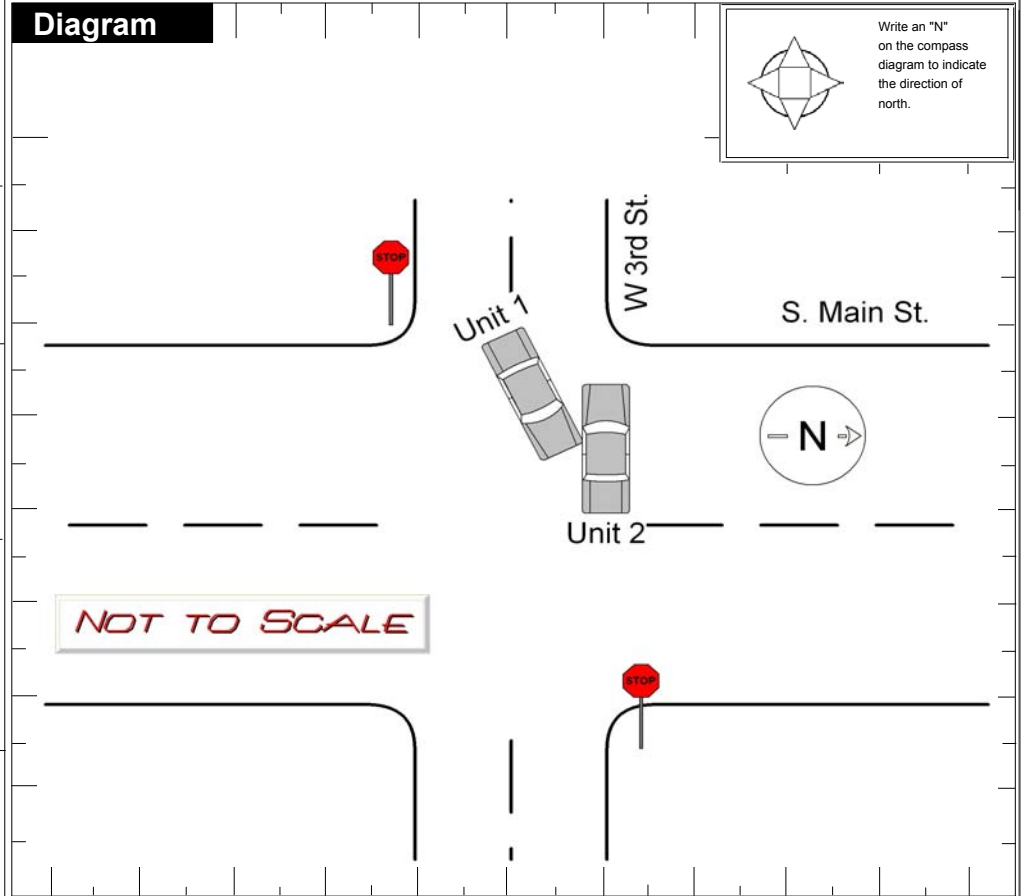
