# Narrative

On 11-14-11 at about 2154 I responded to the intersection of Commerce Center Drive and SR 73 for an accident. When I arrived I spoke to both drivers involved in the accident. The driver of unit number one, Edward Pottenger, was north bound on Conover Dr and making a right turn onto SR 73. Mr. Pottenger said that he had a red light, but that he checked for traffic before making the right turn on red. I spoke to the driver of unit number two, Mr. Paul Gabriel. He was south bound on Commerce Center Dr turning left onto SR 73. He said that he had a green turn arrow and made his turn. He said that as he made his turn Mr. Pottenger made his right turn and struck his vehicle. Damage to the vehicles indicated that events happened as Mr. Gabriel stated. No drivers were cited for this accident.

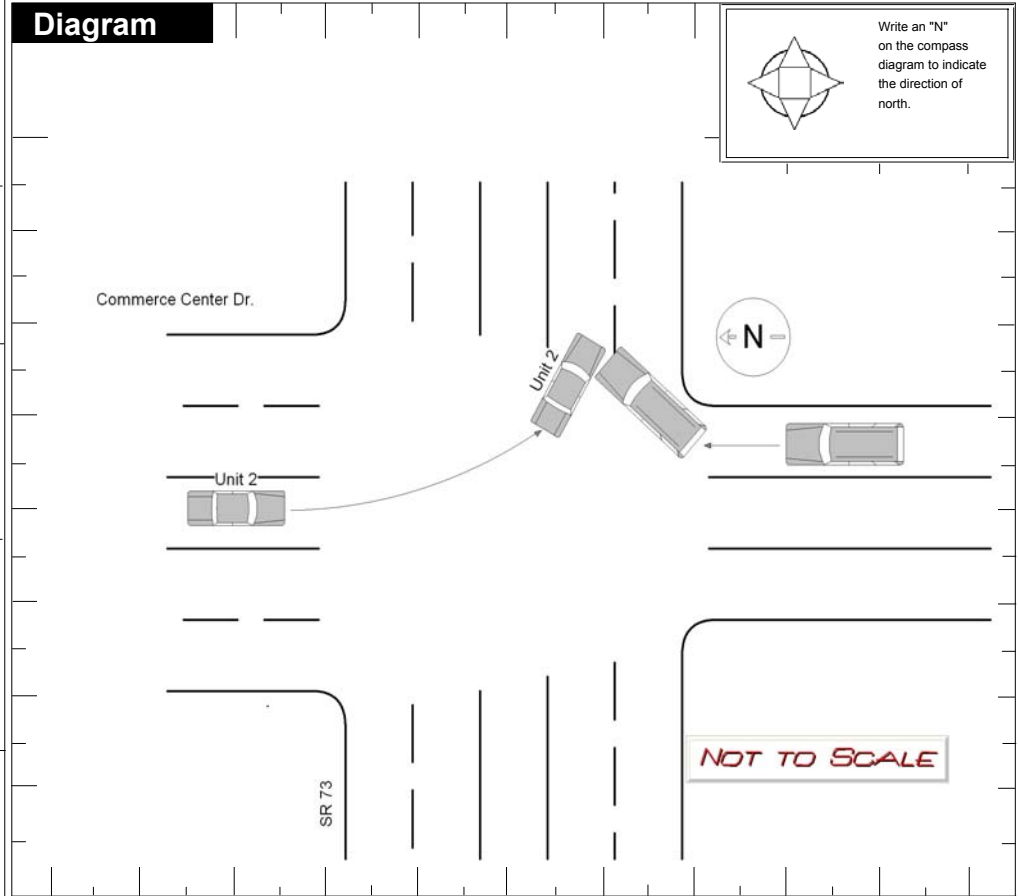
