Narrative

On 10-03-11 at about 1726 I responded to the area of E. Send St. and Locust St. for an accident. When I arrived I spoke to the drivers of both vehicles involved. I found that the driver of unit number one, Rick Beal, was east bound on E. Second St. in the left lane of travel. Mr. Beal attempted to make a lane change to the right lane of travel. Unit number two was moving from west to east on E. Second St. in the right lane of travel. When Mr. Beal made his lane change he struck unit number two. Mr. Beal was issued UTT # 01266 for a marked lane violation. Mr. Beal did not provide proof of insurance at the time of this accident.

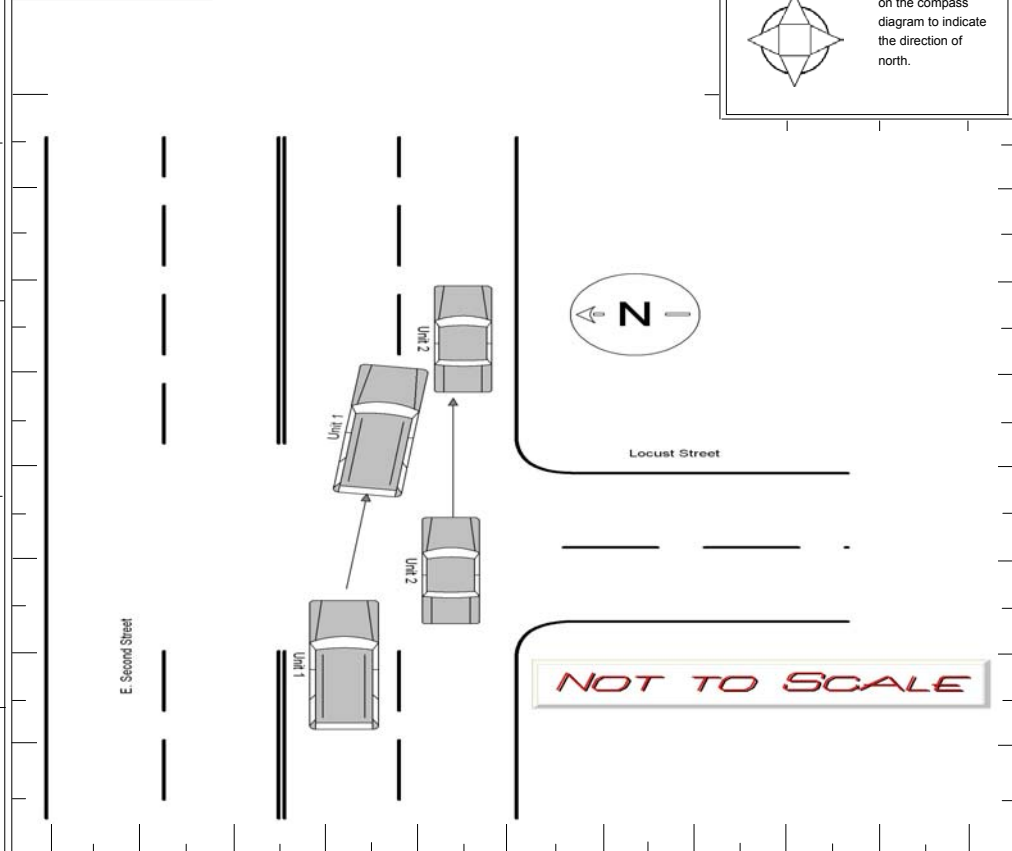
