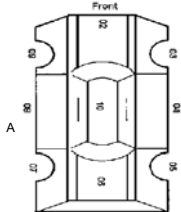
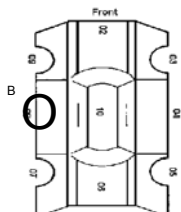

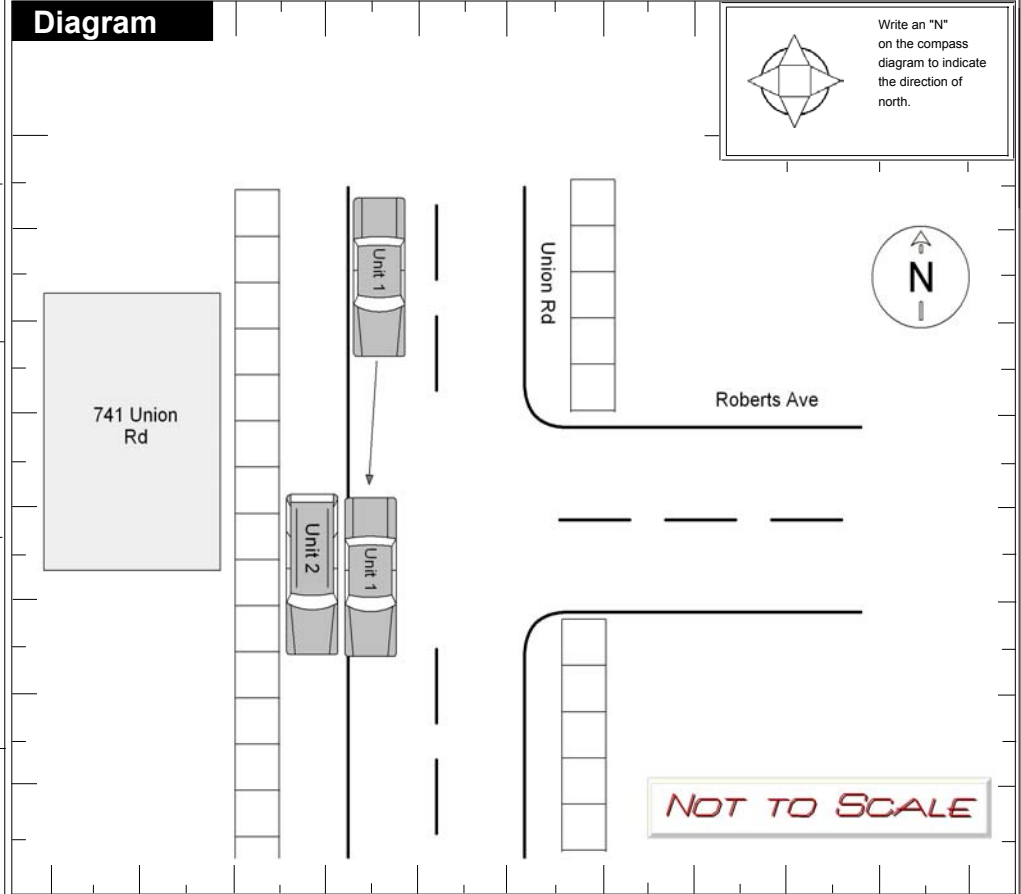

 A truck (motor vehicle) with a GVWR more than 10,000 pounds; or

 An injury requiring transportation for immediate medical treatment; or
 At least one vehicle was towed due to disabling damage or required intervening assistance before proceeding under its own power.
