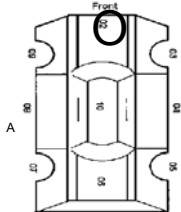


Narrative

Unit #1 sped up and attempted to change into the left lane to avoid a collision with the semi. Driver of Unit #1 stated he did not see Unit #2 stopped in traffic. Unit #1 rear ended Unit #2.

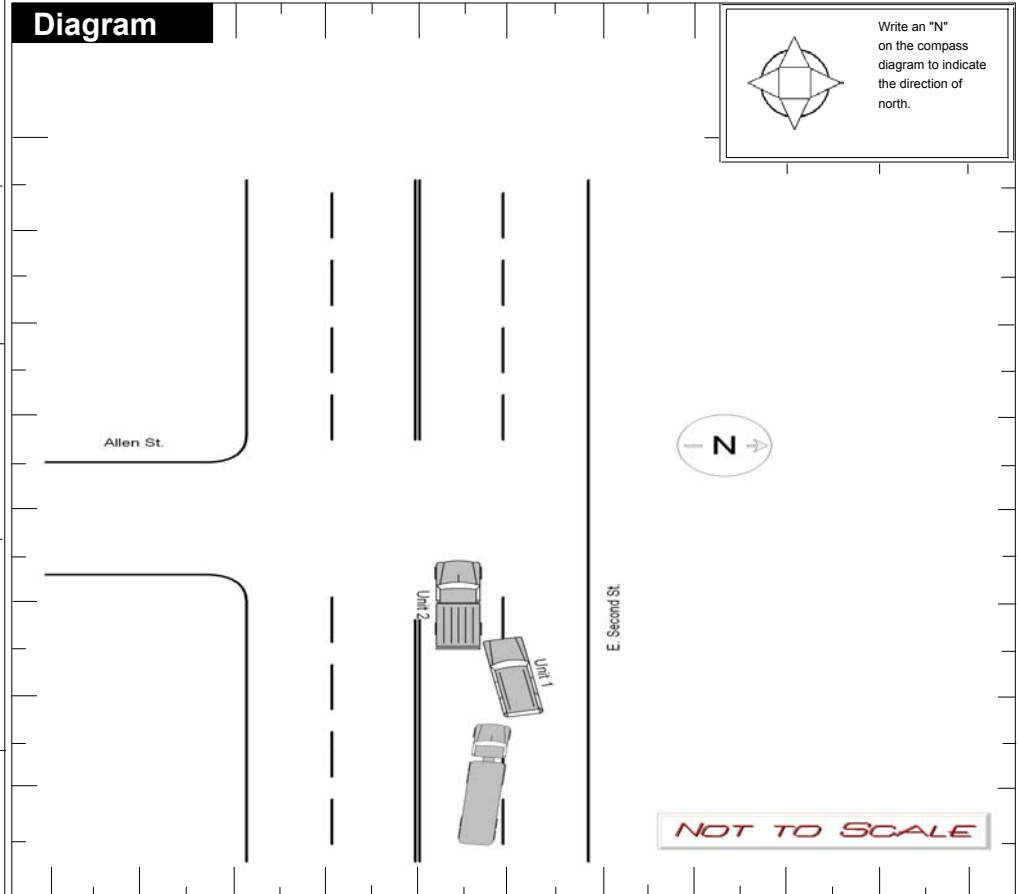
